Youth centre booking conditions :

Bookings must be confirmed in writing by the event organiser by email, fax or letter.
An initial non refundable deposit of £100 per night will be required with the completed booking form

The Youth centre will be ready from 4pm for your arrival and we ask all guests to vacate the youth centre no later than 10am on the day of your departure. If you require to Arrive/Depart at any time other than the preferred times please discuss this with us at the time of your booking.

Youth centre final payment :

Final payment is due six weeks prior to the commencement of the event whether or not a reminder to pay has been sent and cannot subsequently be funded or transferred.

Camping booking conditions and site guidelines:

Bookings must be confirmed in writing by the guest on a booking form, by email, fax or letter together with FULL payment for the whole stay

To protect the nature of the site, groups of more than 4 campers cannot be accepted unless they are a family group with children under the age of 16 years.

Campers under 18 years old must be accompanied by an adult unless they have made prior arrangement with the management.

We do not accept Hen or Stag Parties

We do rely on everyone following our guidelines to maintain our atmosphere of peace and security.

To ensure a pleasant and safe holiday for all, we expect all guests:

- To Respect the property and others guests.
- To avoid disturbance to other guests by arriving no later than 9pm.

A quiet site policy

To avoid excessive noise at all time, being quiet between the hours of 10pm and 7am.

Dogs

To keep dogs on a lead, exercised away from camping areas, and any mess cleared up immediately.

Camp fires and barbeques

Open fires are not permissible but you are welcome to bring charcoal or gas barbeques provided they are raised off the grass, suitably sited and attended so that they are not a hazard to other guests.

Behaviour

Any persons engaging in drunken or excessively rowdy behaviour will not be admitted and/or asked to leave the site.

Cancellation

Payment and acceptance of the initial deposit for the bunkhouse or the fee for camping constitutes a contract. We would advise that guests take out personal travel insurance for their visit.

The final cancellation charge is at the discretion of the General Manager.

Cancellation with less than three months notice - 50% of the total cost of the stay

Cancellation with less than six week's notice - 75% of the total cost of the stay

Cancellation with less than two weeks notice - 100% of the total cost of the stay

Any cancellation must be confirmed immediately in writing.

Refunds No refunds or reductions can be made in respect of meals or accommodation booked but not taken.

Value Added Tax The cost of the booking is inclusive of V.A.T. at the current rate where applicable.

Damages Customers will be liable for the cost of repair of any damage caused to the Bunkhouse or property therein.

Liability Neither the company nor their employees accept any liability for loss or damage to any vehicle or other property belonging to any person or organisation using the Centre.

Rydal Hall reserves the right to refuse or cancel a booking and to ask an individual or group to leave the site immediately at its sole discretion.
